#### Regulations, Terms, Conditions and Rules Governing the Andersontown Powwow

**Electrical Service:** It is understood that the Exhibitor will pay extra for electrical services.

- **Security**: During open hours, there will be Powwow committee volunteers and paid security to help secure your booth. After closing, additional professional security personnel will be on the premises.
- **Liability and Insurance**: The Andersontown Powwow Committee or the staff will <u>NOT</u> be responsible for the safety of the property of the Vendors from theft, damage by fire, accident, or other causes. The Vendor will be responsible for purchasing their own insurance coverage for protection against loss, injury or damage arising out of their negligence in connection with their use and occupancy of the booth space provided.
- **Booth Setup:** Vendors may set up Friday, September 6, 2024, from 9:00am to 8:00pm unless other specific arrangements are made with the Vendor Coordinator. All booths must be set up by 9:00am Saturday, September 7, 2024.
- **Booth Dismantling**: No booth or portion of the booth may be removed during the powwow. Booths must remain complete until the event closes at 4:00pm. Sunday, September 8, 2024.
- Admittance: The Andersontown Powwow may refuse at its sole discretion admittance to any persons whose presence the Committee deems not to be in the best interest of the Andersontown Powwow.
- **Conduct:** Any exhibitor who misrepresents himself/herself or his/her work to the Powwow, or who does not abide by the terms and conditions as set forth will be removed from the event and will not be allowed to exhibit in future years. All exhibitors must conduct themselves in a manner that reflects the dignity of the event. Use of alcohol and smoking by artists/exhibitors or their assistants is prohibited. Failure to follow these rules will result in removal from the event.

# Exhibitor Application & Agreement

### Andersontown Powwow September 7 & 8, 2024

- 1. A booth fee of \$95.00, <u>must</u> be sent with the application and postmarked no later than August 15, 2024, in order to reserve your booth space.
- 2. The Exhibitor shall not move out display before the official closing time which is 4:00pm Sunday, September 8, 2024.
- 3. Merchandise must be authentic for the period and made in North America. The Exhibitor shall provide their own tables/chairs. Tables and Chairs will be provided in the Artist Tent only.
- 4. The Exhibitor shall secure **appropriate license(s)** and/or permit(s) required by the various government agencies prior to the event.
- 5. Exhibitors may not display or sell any items that contain materials derived from animals which are considered endangered or might otherwise be considered in violation of local, state, and/or Federal laws.
- 6. No walk-ins accepted.
- 7. The Exhibitor shall be responsible for procuring their own insurance coverage for protection against loss, injury, or damage to their own or the other person's, arising out of or connected with their use and occupancy of the booth space herein provided for.
- 8. The Powwow will not be liable for the refunds of or any other liabilities whatsoever for the failure to fulfill this contract due to any cause beyond The Powwow's control such as acts of God, public enemy; strikes or statutes or ordinances of any legal authority.
- 9. The Powwow will not be responsible for the safety of the property of the Exhibitor from theft, damage by fire, accident, or other causes, unless due to the negligence of The Powwow.
- 10. The Indiana State Fire Marshall requires all Exhibitors to provide an appropriate fire extinguisher in their booth and prohibits smoking in the tents/booths. A representative of the Indiana State Fire Marshal will conduct an on-site inspection and all rules and regulations/rules must be followed.
- 11. Final Approval of this contract is at the discretion of the Andersontown Powwow.
